This is regarding Compliance Report submitted by **PSG College of Technology, Avinash Road, Peelamedu, Coimbatore- 641 004, Tamil Nadu** for the UG Production Engineering program which was accredited by NBA in Tier-I for academic years 2018-19 to 2020-21 whose validity of accreditation had expired on 30.06.2021.
